Four local government units in Cebu bagged the most coveted CY 2022 Seal of Good Local Governance (SGLG) from the Department of the Interior and Local Government.

They were Talisay City, Danao City, Municipality of Sogod, and Municipality of San Remigio.

The local chief executives and other officials were joined by DILG-7 Director Leocadio Trovela, DILG Cebu Provincial Director Atty. Ian Kenneth Lucero, Provincial Focal Person LGOO V Ginablle Ejoc, and concerned DILG field officers during the national awarding ceremony graced by DILG Secretary Atty. Benjamin Abalos Jr on December 15 at the Manila Hotel.

The awardees received the Governance Assessment Report and SGLG Incentive Fund to finance their local development initiatives.

To recall, the SGLG awardees in Cebu underwent national validation by DILG-CAR in August.

Under Republic Act 11292, the SGLG is an award, incentive, honor, and recognition-based program for all LGUs and is a continuing commitment for LGUs to continually progress and improve their performance in various governance areas.



SGLG onsite assessment held

The Cebu Provincial Government underwent assessment and validation by the DILG-7 Regional Assessment Team as it vies for this year's Seal of Good Local Governance.

The assessment team was composed of DILG-7 Assistant Regional Director Loisella Lucino, DILG Siquijor Provincial Director Dennis Quiñones, DILG Bohol Provincial Director Jerome Gonzales, DILG Negros Provincial Director Farah Gentuya, Local Government Monitoring and Evaluation Division Chief Celerino Magto Jr., and Civil Society Organization Representative Atty. Jonathan Capanas.

During the onsite assessment on April 6, the provincial government team headed by Provincial Administrator Noli Valencia and Chief-of-Staff Atty. Frank Dinsay was assisted by DILG Cebu Province led by Provincial Director Jhoaden Lucero.

Under Republic Act 11292, the SGLG is an award, incentive, honor and recognition-based program for all LGUs and is a continuing commitment for LGUs to continually progress and improve their performance in various governance areas.

To get the prestigious recognition, the LGU must pass the "all-in assessment criteria" which include financial administration and sustainability; disaster preparedness; social protection and sensitivity; health compliance and responsiveness; sustainable education; business-friendliness and competitiveness; safety, peace and order; environmental management; tourism, heritage development, culture and arts; and youth development.

Cebu LTIA 2022 commences

The Lupong Tagapamayapa Incentives Awards (LTIA) Cebu Provincial Awards Committee (PAC) kicked off the onsite validation and assessment in November in the barangays shortlisted as this year's finalists.

Vying the most outstanding Lupong as Tagapamayapa are Barangay Sta. Cruz, Ronda, Tagnucan, Borbon and Barangay Barangay Villahermosa, Tudela for the 4th to 6th class Barangay municipalities category; Lamac. Pinamungajan, Barangay Poblacion Liloan, and Barangay South Poblacion, San Fernando for the 1st to 3rd class municipalities category; and Barangay Gairan, Bogo City, Barangay Uling, City of Naga, and Barangay Poblacion, Danao City for the component cities category.

DILG Cebu Provincial Director and PAC Co-Chairperson Atty. Ian Kenneth Lucero was joined by members Atty. Jeah Gacang of the Integrated Bar of the Philippines Cebu Chapter, Atty. Nel Ediza of the Provincial Legal Office, Pros. Liewellyn Bonghanoy of the Provincial Prosecutor's Office, Lito Layao of the Liga ng mga Barangay Cebu Chapter, and Atty. Mark Gregory Avila and Atty. Christian Arenajo of the Young Lawyers Association of Cebu.

They reviewed the documents and interviewed the members of the Lupong Tagapamayapa of the contending barangays as to their innovations and best practices in the administration of Katarungang Pambarangay.

The winners of Cebu LTIA CY 2022 will be announced and awarded on January 6, 2023.

This year, Governor Gwendolyn Garcia allocated over P1.3 million for the winning barangays to fund their infrastructure projects and other expenses for the LTIA awarding ceremony.



REGIONAL AWARDING SGLGB, LTIA awardees recognized

The DILG-7 gave recognition to the national passers of the 2021 Seal of Good Local Governance for Barangays (SGLGB), including four barangays in Cebu Province, during a regional awarding ceremony on November 8.

DILG-7 Director Leocadio Trovela was assisted by DILG Cebu Provincial Director Atty. Ian Kenneth Lucero in awarding the plaques and certificates/letters of commendation to the punong barangay of Barangay Tugas in Madridejos; Barangays To-ong and Calambua in San Remigio; and Barangay Mohon in Sogod.

Also present were Provincial Focal person LGOO V Ginable Ejoc, San Remigio MLGOO Claire Diaz, Sogod MLGOO Sheila Denden, and Madridejos OIC-MLGOO John Michael Legaspi.

SGLGB is a progressive assessment system that gives distinction to the remarkable performance of barangays in various governance areas, putting primacy integrity and good performance in pursuit for meaningful local autonomy and development.

On the same day, the DILG Regional Office also conferred awards to the regional winners of CY 2022 Lupong Tagapamayapa Incentives Awards (LTIA).

Barangay Nasipit, Barili, Cebu was hailed as the Regional Winner under the 1st to 3rd Class Municipalities category.

Barangay Uling, City of Naga, Cebu and Barangay Villahermosa, Tudela, Cebu meanwhile placed 1st runner-up in the Component Cities category and 4th to 6th Class Municipalities category, respectively.

36 LGUs named GFH passers

At least 36 local government units in Cebu Province passed the CY 2021 Good Financial Housekeeping (GFH) nationwide assessment of the Department of the Interior and Local Government (DILG).

These LGUs were Alcoy, Alegria, Aloguinsan, Asturias, Badian, Balamban, Barili, Bogo City, Boljoon, Carcar City, Catmon, Consolacion, Cordova, Daanbantayan, Dalaguete, Danao, Dumanjug, Liloan, Madridejos, Malabuyoc, Medellin, Moalboal, Naga City, Ronda, Samboan, San Fernando, San Remigio, Santa Fe, Santander, Sibonga, Sogod, Tabogon, Tabuelan, Talisay City, Tuburan, and Tudela.

DILG Cebu Provincial Director Atty. Ian Kenneth Lucero congratulated the LGU passers on their achievement which he said clearly proves their firm commitment and strong political will towards financial transparency.

"Continue to champion better fiscal management as it hopefully translates to enhanced delivery of services to the communities and eventually solidifies the trust of the people to the government," his congratulatory letter read.

The GFH measures the financial transparency and institution of public reporting of budget and expenditures of local governments.














Barangay Assembly Day conducted

All 1,066 barangays in Cebu Province have conducted Barangay Assembly (BA) Day for the second semester of 2022.

The theme was "Barangayanihan: Barangay at Mamamayan Sama-Sama sa Pagtaguyod ng Bayanihan Tungo sa Mas Ligtas at Maunlad na Pamayanan."

The Department of the Interior and Local Government earlier issued an advisory extending the period for the conduct of BA Day on any of the Saturdays or Sundays from October to November since some barangays were affected by the onslaught of Tropical Storm Paeng on October 28.



CSO Conference held



The Cebu Provincial Government, in collaboration with the DILG Cebu Province, gathered the civil society organizations (CSOs) in the province on August 16 for a conference pursuant to DILG Memorandum Circular No. 2022-083.

Concurrent with the issuance of the call for accreditation, the CSO Conference aims to orient the participants on the accreditation guidelines and raise their awareness on the importance of civil society participation in the local governance processes, and to encourage CSOs to apply for accreditation with their local sanggunian.

DILG Cebu Provincial Director Atty. Ian Kenneth Lucero said the government recognizes the need to empower the citizens by providing them avenues where they can actively participate.

Program Manager LGOO VI Rothwel Pulido discussed the Guidelines on the Accreditation of CSOs and Selection of Representatives to the Local Special Bodies, while Provincial Focal Person LGOO V Iris Arias discussed the Relevance of Participatory Governance, Code-mandated Avenues for Participation and the Local People's Council.

Dean Caratao from the Office of Hon. Victoria Corominas-Toribio, Sangguniang Panlalawigan Chair on CSO Accreditation, likewise informed the CSOs on the provincial government's accreditation process, required documents, and timeline.

After the CSO Conference, the CSOs who attended shall submit the requirements for accreditation, or renewal, to the sanggunian.

DILG Cebu joins CSO Conference orientation

Provincial Director Atty. Ian Kenneth Lucero and technical personnel of DILG Cebu Province attended the Visayas-Mindanao orientation on the conduct of Civil Society Conference (CSO) Conference at Bai Hotel, Mandaue City on June 30.

LGOO VI Rothwel Pulido, LGOO V Iris Arias, and LGOO II Randel Cedie Samonte joined other focal persons on CSO accreditation from other regions and DILG-7 subregional offices.

The participants shall cascade the orientation online to the DILG field officers who will orient their LGU functionaries such as the Local Planning Development Coordinators, CSO desk officers and/or other duly designated LGU appointive officials in preparation for the CSO conference in the first week of August.

The activity was spearheaded by CSO/People's Participation Partnership Program-Program Management Office (CSO/PPPP-PMO), DILG-Support to Local Governance Program -Project Management Office (SLGP-PMO), and DILG Region 7 as host region.



The topics discussed were Overview of DILG's CSO Engagement Roadmap and Objectives of the Session; Policy Briefing on the Amendment to DILG Memorandum Circular 2019-72 entitled Guidelines on the Civil Accreditation of Society Selection Organizations and Representatives to the Local Special Bodies: and Capacity Development Program for CSOs in the LSBs, among others.

DILG Cebu joins CSO CapDev TOT

The DILG Cebu Province joined the hybrid regional training of trainers on the Capacity Development Program for Civil Society Organizations (CSOs) in Local Special Bodies (LSBs) on August 22 to 26 at Bai Hotel, Mandaue City.

Present were Cluster Head CH Roxine Coyoca, Provincial CSO focal person LGOO V Iris Arias, City and Municipal Local Government Operations Officers, LGU functionaries from the local planning, local health and local social welfare and development offices, CSO desk officers, and others in charge of capacity development.

The activity aimed to capacitate the LGUs and external trainers on the content and approach in delivering the modules for the Local Development Council, Local School Board, and Local Health Board; module exercises to ensure uniformity and exchange for effective training delivery; and pointers for the nationwide rollout to be conducted.





DILG Cebu releases P900k death benefits



The Department of the Interior and Local Government (DILG) Cebu Province released a total of P912,000 death benefits to the beneficiaries of 66 deceased barangay officials from January to June this year.

Of these barangay officials, 12 were punong barangay (PB), 52 were sangguniang barangay members (SBM), and two were barangay secretaries.

DILG Cebu Provincial Director Atty. Ian Kenneth Lucero, cluster heads, and field officers handed over the cheques to the beneficiaries.

Pursuant to Executive Order No. 115, series of 2002, the DILG is authorized to determine the amount and administer the payment of the death benefits of barangay officials who die during their term of office.

Beneficiaries of a deceased punong barangay can receive P20,000 for death benefit and P2,000 for burial expenses, while beneficiaries of a deceased member of a sangguniang barangay, including Sangguniang Kabataan chairpersons as ex-officio members, barangay secretary and barangay treasurer, can receive P10,000 death benefit and P2,000 for burial expenses.

The death benefit claims can be processed online through the Barangay Information System.

DILG Cebu releases death benefit claims



DILG Cebu Provincial Director Atty. Ian Kenneth Lucero led the distribution of death benefit checks to at least 17 beneficiaries of barangay officials in Cebu Province who died during their term of office.

Beneficiaries of a deceased punong barangay received P22,000, while beneficiaries of a deceased member of a sangguniang barangay, including its Sangguniang Kabataan (SK) chairpersons as ex-officio members, barangay secretary and barangay treasurer, received P12,000.

The distribution was conducted during the local legislation training organized by DILG Cebu and Philippine Councilors League Cebu Federation for neophyte legislators on July 15.

These beneficiaries likewise received gallons of alcohol, vitamins, and face masks from the DILG Cebu Province.

Meanwhile, other beneficiaries likewise claimed the death benefit checks from the Provincial Office and field offices.





Department heads and personnel of the Municipality of Dumanjug, Cebu participated in the Citizen Satisfaction Index System (CSIS) utilization conference on June 15.

Mayor Efren Gica thanked the DILG Regional Office, DILG Cebu Province, and DILG Dumanjug for spearheading the conduct of the activity, and vowed to support the plans and programs under the Citizen-Driven Action Plan which would be formulated during the conference.

On behalf of DILG Cebu Provincial Director Atty. Ian Kenneth Lucero, Cluster Head Roxine Coyoca expressed hopes that the municipality can come up with interventions and proposals to improve the service delivery.

Project Manager Jesse Susada of the University of San Jose-Recoletos as DILG-7 Local Resource Institute partner presented the comprehensive CSIS survey report and turned it over to the Municipality and DILG.

Also present were the Civil Society Organization/People's Participation Partnership Program (CSO/PPPP) Project Management Office headed by John Denver Calo, personnel from DILG regional, provincial, and field offices, and several CSOs.

FDP compliance intensified



Newly installed DILG Cebu Provincial Director Atty. Ian Kenneth Lucero directed all cluster heads and City and Municipal Local Government Operations Officers (C/MLGOOs) to intensify the compliance of their respective LGUs with the Full Disclosure Policy (FDP).

In a Memorandum dated June 16, 2022, Lucero issued a Memorandum ensuring the full compliance of the LGUs with the uploading and posting of financial documents in the FDP portal for March 15, 2022 and June 15, 2022.

As of June 30, DILG Cebu posted 90.19% compliance rate for the first semester this year - the highest in the province since 2021.

Out of the 51 LGUs, only 10 were not able to comply with the FDP posting requirement.

The FDP, which requires LGUs to disclose particular financial documents and make them accessible to the public, is issued in accordance with the constitutional mandate of promoting good governance through transparency, accountability and participation.

Garcia declares all-out war vs illegal drugs

Governor Gwendolyn Garcia has declared a total all-out war against illegal drugs in the province during the joint meeting of Provincial Development Council (PDC), Provincial Peace and Order Council (PPOC), Provincial Anti-Drug Abuse Council (PADAC), and Provincial Disaster Risk Reduction and Management Council (PDRRMC) September 15.

She urged all local chief executives of the component local government units in the province and officials of local and national government agencies to unite in this endeavor.

Garcia's declaration was adopted and supported by PDC. PPOC, PADAC, and PDRRMC, which she all chairs, through a joint resolution passed during the said meeting.

DILG Cebu Provincial Director Atty. Ian Kenneth Lucero, head secretariat of PPOC, thanked Garcia for making the joint meeting possible.

Lucero presented the Peace and Order and Public Safety (POPS) Plan and PADAC Plan, which were also approved during the meeting.

Meanwhile, the Cebu Provincial Management Coordinating Committee, chaired by Lucero, passed Resolution Nos. 8 and 9, series of 2022, supporting and commending Garcia for making such declaration.





GARCIA CREATES ONE CEBU INTER-AGENCY INTERDICTION TASK FORCE

Gov. Gwen Garcia officially signed on Tuesday a memorandum of agreement with several agencies, led by the Police Regional Office 7, for the creation of the One Cebu Inter-Agency Interdiction Task Force in what is the country's first collaborative, localized fight against illegal drugs.

The momentous agreement signals the start of a unified effort among law-enforcement bodies and other agencies in battling illegal drug smuggling into and trade in Cebu.

"Dinhi sa atong pinalanggang Sugbo, ipakita nato that this is the way to go. Only by calling on and joining hands with all good men and women, with their respective mandates of their respective s government agencies in a unified, collaborative effort, we can truly make a huge difference against this fight and war. In a most holistic approach, we will conquer this menace," Gov. Gwen said in her speech during the signing ceremony.

The task force consists of 13 government and non-government agencies. The signatories of the MOA included the PRO 7, PDEA 7, Cebu Port Authority, MCIAA, Bureau of Customs Cebu, Marina 7, NBI 7, NICA 7, Bureau of Immigration, Integrated Bar of the Philippines Cebu Province and Cebu City Chapters, and Civil Aviation Authority of the Philippines.

The first phase of the task force's integrated antidrug campaign involves the reduction of supply of illegal drugs coming to Cebu Island. The group's goal will also soon target drug operations within the province and the prosecution of drug cases.



"We will make it very, very hard for these drug suppliers to make Cebu their marketplace. Over here in Cebu, we don't do things for photo-ops or press releases. That (MOA signing) is just a symbolic gesture. Now, watch us translate the terms of that MOA into action – buhat ang pasultion," Gov. Gwen said.

Gov. Gwen will function as head of the task force. She said a command center will soon be put up at the Capitol for the group.

The governor has been relentless in her intent to make Cebu drug-free, or at least eradicate the supply coming to Cebu, saying that the menace of illegal drugs cannot be overemphasized.

She said this was the first of its kind drug campaign collaboration in the Philippines, where several agencies have come together in a localized anti-drug battle.

These LGUs garnered perfect scores in both functionality and awarding assessments during last year's performance audit.

DILG Cebu Provincial Director Atty. Ian Kenneth Lucero commended San Francisco Mayor Alfredo Arquillano and Poro Mayor Edgar Rama for their "commitment and hard work in safeguarding the citizenry from the harmful effects of dangerous drugs by giving priority to preventive or educational programs, rehabilitation or treatment of drug users/dependents, and reformation of drug pushers."

"Atong timan-an, Buhay Ingatan, Droga'y Ayawan! Once again, congratulations," Lucero's congratulatory letter read.





Cebu LGUs kick off RCSP activities



Several local government units in Cebu Province commenced the activities for the second phase of the Retooled Community Support Program (RCSP) in October and November.

These LGUs were Moalboal, Talisay City, Minglanilla, and Barili.

The kickoff activities, which included the unveiling of the Dagyawan sa Barangay peace poles and oath taking of the local RCSP teams, were graced by local chief executives, other local officials, DILG Cebu Province headed by Provincial Director Atty. Ian Kenneth Lucero, field officers, and other partner agencies.

"Atong itukod kining usa ka monumento nga kanunay magpahinumdom kanato sa atong nagkaiusang tinguha alang sa kalinaw", Lucero said, referring to the peace pole.

Badian, San Fernando produce CBDRP completers



Around 390 former drug dependents from the Municipalities of Badian (194) and San Fernando (196) have completed the six-month rehabilitation and treatment under the Community-Based Drug Rehabilitation Program (CBDRP).

DILG Cebu Provincial Director Atty. Ian Kenneth Lucero lauded Mayor Carmencita Lumain, Mayor Mytha Ann Canoy, barangay and municipal officials, DILG field officers, and others involved for the successful implementation of the program.

He mentioned that DILG Secretary Atty. Benjamin Abalos Jr. recently launched the "Buhay Ingatan, Droga'y Ayawan" (BIDA) national advocacy program which aims to reduce the demand for illegal drugs, show respect for the law and human rights, and focus on rehabilitation and socio-economic development.

"Sa tinud-anay, dili ni kaya sa gobyerno o kapulisan lang. Busa, nanghinaut ako nga magkahiusa ug magtinabangay kitang tanan sa pakigbisog sa iligal nga droga alang sa kaayohan sa tanan," he said.

Lucero also handed the certificates of recognition conferred to the Municipality of San Fernando for earning high functional score and moderate functional score in the 2019 and 2020 Anti-Drug Abuse Council Performance Audit, respectively.

The municipalities of Tabuelan and Madridejos placed 1st and 2nd, respectively, among the LGUs with the highest number of Safety Seals issued to registered establishments.

On the other hand, earning the highest percentage of establishments issued with Safety Seals were Pinamungajan (1st place under Municipalities category), Bogo City (2nd place under Component Cities/Independent Component Cities category), and Asturias and Balamban (2nd and 3rd place, respectively, under Municipalities category).

Personnel of DILG Cebu Project Development and Management Unit (PDMU) inspected and validated the locally funded projects (LFPs) in several local government units in the Province to monitor the actual status of their implementation.

Among these LFPs were completed, ongoing and upcoming concreting/upgrading of local access roads in Asturias, Badian, Boljoon, Carcar City, Carmen, Catmon, Dalaguete, Danao City, Malabuyoc, Pinamungajan, and Sibonga.

These also included projects in Alcantara; installation of street lights and other upcoming projects in Alegria; concreting of farm-to-market road and repair/rehabilitation of barangay road networks affected by Typhoon Odette in Balamban; rehabilitation of streets in Pilar; construction of multipurpose hall, water project and road project in Poro; road projects, public market and purchase of ambulance in Samboan; and purchase of medical equipment in Tudela.

All these LFPs were funded under the Financial Assistance to Local Government Units (FALGU) FY 2021 and FY 2022, Assistance to Municipalities 2020, and Conditional Matching Grant to Provinces (CMGP) 2020.

Part of the onsite validation were the updating of the SubayBAYAN online monitoring system and exit conference securing the commitment of LGUs to complete the projects before yearend.

Meanwhile, the PDMU engineers provided onsite technical support during the video documentation of completed LFPs in San Fernando (149.4 million), Ronda (P22 million), and Alcantara (P4.3 million).

DILG Cebu supports "Dasig Pescador"





Department of the Interior and Local Government (DILG) Cebu Provincial Director Jhoaden Lucero expressed support for the launch of "Dasig Pescador", a volunteer campaign seeking to expedite the rehabilitation of Pescador Island in Moalboal, Cebu.

To recall, the island was temporarily closed after it was damaged by Typhoon Odette in December 2021.

The government-led initiative, which was formally launched on February 27, was spearheaded by Governor Gwendolyn Garcia in partnership with the Department of Tourism, signaling the reopening of the famous diving spot to tourists.

Recognizing that Moalboal is one of the most visited tourist destinations in the province, the Cebu Provincial Tourism Task Force has come up with intervention measures to speed up coral recovery and restore tourism livelihood in the area.



Tourism recovery eyed



To address issues and concerns from the tourism stakeholders, the Cebu Provincial Tourism Task Force conducted a dialogue on February 26 in Moalboal, Cebu.

Governor Gwendolyn Garcia, who heads the task force, tackled the efforts undertaken by the provincial government to revive the tourism industry following the COVID-19 pandemic and Typhoon Odette.

Department of the Interior and Local Government (DILG) Cebu Provincial Director Jhoaden Lucero meanwhile commended Garcia and the concerned offices, and vowed to support the programs and activities intended for tourism recovery.

DILG Cebu Provincial Director Jhoaden Lucero took a step up the career ladder after having been appointed as Director III and promoted as the Assistant Regional Director in DILG Region V.

She took her oath before Undersecretary for Local Government Marlo Iringan on March 9.

Lucero served as the city director of DILG Mandaue City from 2010 to 2019 and took the helm of DILG Cebu Province from 2020 to 2022.

Among her major accomplishments and initiatives in DILG Cebu were the active participation and support of the provincial government headed by Governor Gwendolyn Garcia to the programs and activities of the Department; and the 'One-Link' guide to all their deliverables, deadlines, reporting templates, and schedule of activities.

Lucero likewise made it a priority under her leadership to increase the number of LGUs with approved Comprehensive Development Plan (CDP) by creating a team that will focus on providing technical assistance to the LGUs. From only six LGUs with approved CDP when she assumed office as DILG Cebu Provincial Director, at least 40 out of the 50 LGUs of the Province already now have approved CDP as of June 30, 2022.

Following her promotion and reassignment to Bicol Region, she was replaced by her husband and former DILG Cebu City director, Atty. Ian Kenneth Lucero who now heads the DILG Cebu. They have two children.

Atty. Ian Kenneth Lucero, former DILG Cebu City director and current DILG Cebu Provincial Director, was named as a national finalist for the most coveted Dangal ng Kagawaran (People's Choice) of the 2022 Capacity Development Awards for Catalysts of Excellence (CapDev ACE).

DILG Cebu receives office equipment






Lucero recently released three new episodes of APO SHARES, making the total number of episodes to seven at the end of the second quarter of 2022.





G.R. No. 218663, February 28, 2022 (Second Division)

MUNICIPALITY OF CORELLA, represented by MAYOR JOSE NICANOR D. TOCMO. Petitioners, vs. PHILKONSTRAK DEVELOPMENT CORPORATION and VITO RAPAL, **Respondents.**

FACTS:

The Municipality of Corella in Bohol, through then mayor Rapal, entered into a contract agreement with Philkonstrak for the rehabilitation and improvement of the municipal waterworks system for a total ISSUES: amount of P15,997,732.63.

As of December 2009, Philkonstrak accomplished more than 50% of the work essential for the project and demanded Corella to pay for the actual expenses it incurred in the amount of P8,233,000.00.

Corrella, through now Mayor Tocmo, refused to pay and denied liability, questioning the validity of the contract and averring that Rapal had no authority to enter into such contract.

Philkonstrak filed before the Construction Industry Arbitration Commission (CIAC) a complaint for collection of sum of money against Corella and Rapal.

Rapal averred that he was authorized to enter into the contract with Philkonstrak in accordance with Municipal Ordinance No. 2010-0228 or "An Ordinance Appropriating the Amount of Twenty-Seven Million Pesos (Php 27,000,000.00) for the Purchase of the Following Heavy Equipment: One Unit Brand New Road Grader, One Unit Reconditioned Road Roller, and Rehabilitation/Improvement on the Existing Waterworks System of the Local Government Unit]."

Corella asserted that the contract is not binding because Municipal Ordinance No. 2010-02 was in violation of Article 107(g) of the Implementing Rules and Regulations (IRR) of Republic Act No. 7160 otherwise known as the "Local Government Code (LGC) of 1991."

The CIAC issued a Decision finding the contract between Philkonstrak and Corella to be valid, which was affirmed by the Court of Appeals (CA).

- Whether or not a separate Sangguniang Bayan authorization still is necessary when the appropriation ordinance is sufficient in detail.
- Whether or not an appropriation ordinance requires the affirmative vote of a majority of all the Sangguniang members.
- Whether or not the Principle Quantum Merit applicable in this case.

RULINGS:

1. No separate sangguniang authorization bayan is necessary when the appropriation ordinance is sufficient in detail.

Tocmo asserts that before then Mayor Rapal entered into the contract on behalf of Corella with Philkonstrak, two requirements were necessary to be met: (1) prior authorization from the sangguniang bayan of Corella, in accordance with Section 22(c) of LGC and Section 37 of the Government Procurement Act; and (2) the appropriation ordinance resolution or authorizing or directing payment of money or creating a liability, in accordance with Article 107(g) of the IRR of the LGC.

The Court disagrees. In the landmark case of Quisumbing v. Garcia, the Court delineated when a sangguniang bayan authorization is still necessary accompany the appropriation ordinance and when it is not. Depending on the circumstances of the case, if the project is provided for in sufficient detail in the appropriation ordinance, meaning the transactions, bonds, contracts, documents, and other obligations the mayor would enter into in behalf of the municipality, among others, are enumerated, then separate authorization necessary. On the other hand, if the project is merely couched in general and generic terms, then a separate approval by the sangguniang bayan in accordance with the law is required.

In the case at bar, the one-paged appropriation ordinance specifically and expressly set aside an amount of money, P27,000,000.00, for certain projects, including the purchase of specific heavy equipment rehabilitation/improvement of the existing waterworks system of the municipality. Municipal Ordinance No. 2010-02, having sufficiently covered the project and the cost in detail, need not be accompanied by a prior sangguniang bayan authorization any longer.

2. An appropriation ordinance requires the affirmative vote of a majority of all the sanggunian members.

G.R. No. 218663, February 28, 2022 (Second Division)

MUNICIPALITY OF CORELLA, represented by MAYOR JOSE NICANOR D. TOCMO, Petitioners, vs. PHILKONSTRAK DEVELOPMENT CORPORATION and VITO RAPAL, Respondents.

Article 107(g) of the IRR of the LGC provides the general rule that no ordinance or resolution shall be passed by the sanggunian without prior approval of a majority of all the members present. The exception to the general rule is that for ordinances or resolutions authorizing or directing the payment of money or creating a liability, what is needed is the affirmative vote of a majority of all the sanggunian members, whether present or not. Simply, the quorum in the general rule depends on the number of the sanggunian members present while the quorum in the exception depends on the total number of sanggunian members voted into office

In the case at bar, Corella asserts that Municipal Ordinance No. 2010-02, the appropriation ordinance in question, directs and authorizes the payment of money: thus, requires a majority vote of all the members of the sangguniang bayan, not only of the members present. Thus, since the sangguniang bayan of Corella is composed of a total of 11 members, the majority vote of six is required in order for Municipal Ordinance No. 2010-02 to be valid and binding. However, the municipal ordinance only obtained five affirmative votes, based on the quorum on the sanggunian members present at that time, which was eight members. Thus, Tocmo contends that Municipal Ordinance No. 2010-02 is null and void. Consequently, the contract between Corella and Philkonstrak is null and void too.

The term "appropriation," as defined under Section 306, Title V of the Local Government Code "refers to an authorization made by ordinance, directing the payment of goods and services from local government funds under specified conditions or for specific purposes."

Juxtaposing this definition with the exception in Article 107(g) of the IRR of the Local Government Code, that "any ordinance x x x authorizing or directing the payment of money x x x, shall require the affirmative vote of a majority of all the sanggunian members," it is express and clear that an "appropriation ordinance" is one such ordinance contemplated in the exception.

The definition of the term "appropriation" in the LGC is clear: [i]t is an authorization made by an ordinance that directs the payment of money. The exception to the general rule prescribed of the voting requirement in the IRR of the LGC is clear: an ordinance that or authorizes the directs payment of money needs a quorum of all the sanggunian members, not only of those sanggunian members present.

3. The principle of quantum meruit is applicable in this case.

Quantum meruit literally means "as much as he deserves." This legal principle, a principle predicated on equity, states that a person may recover a reasonable value of the thing he delivered or the service he rendered. It is a device to prevent undue enrichment based on the equitable postulate that it is unjust for a person to retain a benefit without paying for it.

The Court has held in the past that recovery on the basis of quantum meruit is allowed despite the invalidity or absence of a written contract between contractor and а government agency. The absence or invalidity of required documents would necessarily not preclude the contractor from receiving payment for the services he or she has rendered for the government.

Thus, in the case at bar, despite the invalidity of Municipal Ordinance No. 2010-02, which in turn rendered the contract between Corella and Philkonstrak, invalid, the latter is still entitled to receive payment for the services it rendered for the local government of Corella. Corella cannot be unjustly enriched and allowed to retain the benefits of the services rendered by Philkonstrak without properly paying for it.

GOV. LUIS RAYMUND F. VILLAFUERTE, JR., and the PROVINCE OF CAMARINES SUR, Petitioners, vs. HON. JESSE M. ROBREDO, in his capacity as Secretary of the Department of the Interior and Local Government, Respondent.

DILG MCs not infringement of local and fiscal autonomy

FACTS:

In 1995, the Commission on Audit (COA) conducted an examination and audit on the manner the local government units (LGUs) utilized their Internal Revenue Allotment (IRA) for the calendar years 1993-1994. The examination yielded an official report, showing that a substantial portion of the 20% development fund of some LGUs was not actually utilized for development projects but was diverted to expenses properly chargeable against the Maintenance and Other Operating Expenses (MOOE), in stark violation of Section 287 of R.A. No. 7160, otherwise known as the Local Government Code of 1991 (LGC).

Subsequently, the late Honorable Jesse M. Robredo (respondent), in his capacity as then Secretary of the Department of the Interior and Local Government (DILG), issued the following issuances:

- (a) Memorandum Circular (MC) No. 2010-83 dated August 31, 2010, pertaining to the full disclosure of local budget and finances, and bids and public offerings;
- (b) MC No. 2010-138 dated December 2, 2010, pertaining to the use of the 20% component of the annual internal revenue allotment shares; and
- (c) MC No. 2011-08 dated January 13, 2011, pertaining to the strict adherence to Section 90 of Republic Act (R.A.) No. 10147 or the General Appropriations Act of 2011.

Former Governor Luis Raymund F. Villafuerte, Jr. and the Province of Camarines Sur (petitioners) filed a petition for certiorari and prohibition seeking to annul and set aside the aforementioned issuances on the ground of unconstitutionality and for having been issued with grave abuse of discretion amounting to lack or excess of jurisdiction.

ISSUE:

Whether or not the assailed memorandum circulars violate the principles of local and fiscal autonomy enshrined in the Constitution and the LGC.

RULING:

No. The assailed memorandum circulars do not transgress the local and fiscal autonomy granted to LGUs.

A reading of MC No. 2010-138 shows that it is a mere reiteration of an existing provision in the LGC. It was plainly intended to remind LGUs to faithfully observe the directive stated in Section 287 of the LGC to utilize the 20% portion of the IRA for development projects.

It was, at best, an advisory to LGUs to examine themselves if they have been complying with the law. It must be recalled that the assailed circular was issued in response to the report of the COA that a substantial portion of the 20% development fund of some LGUs was not actually utilized for development projects but was diverted to expenses more properly categorized as MOOE, in violation of Section 287 of the LGC.

Contrary to the petitioners' posturing, however, the enumeration was not meant to restrict the discretion of the LGUs in the utilization of their funds. It was meant to enlighten LGUs as to the nature of the development fund by delineating it from other types of expenses. It was incorporated in the assailed circular in order to guide them in the proper disposition of the IRA and avert further misuse of the fund by citing current practices which seemed to be incompatible with the purpose of the fund. Even then, LGUs remain at liberty to map out their respective development plans solely on the basis of their own judgment and utilize their IRAs accordingly, with the only restriction that 20% thereof be expended for development projects.

The petitioners likewise misread the issuance by claiming that the provision of sanctions therein is a clear indication of the President's interference in the fiscal autonomy of LGUs. Significantly, the issuance itself did not provide for sanctions. It did not particularly establish a new set of acts or omissions which are deemed violations and provide the corresponding penalties therefor. It simply stated a reminder to LGUs that there are existing rules to considering the disbursement of the 20% development fund and that noncompliance therewith may render them liable to sanctions which are provided in the LGC and other applicable laws. Nonetheless, this warning for possible imposition of sanctions did not alter the advisory nature of the issuance. At any rate, LGUs must be reminded that the local autonomy granted to them does not completely severe them from the national government or turn them into impenetrable states. Autonomy does not make local governments sovereign within the

As in MC No. 2010-138, the Court finds nothing in two other questioned issuances of the respondent, i.e., MC Nos. 2010-83 and 2011-08, that can be construed as infringing on the fiscal autonomy of LGUs. The petitioners claim that the requirement to post other documents in the mentioned issuances went beyond the letter and spirit of Section 352 of the LGC and R.A. No. 9184, otherwise known as the Government Procurement Reform Act, by requiring that budgets, expenditures, contracts and loans, and procurement plans of LGUs be publicly posted as well.

It is well to remember that fiscal autonomy does not leave LGUs with unbridled discretion in the disbursement of public funds. They remain accountable to their constituency. For, public office was created for the benefit of the people and not the person who holds office.

The assailed issuances of the respondent, MC Nos. 2010-83 and 2011-08, are but implementation of this avowed policy of the State to make public officials accountable to the people. They are amalgamations of existing laws, rules and regulation designed to give teeth to the constitutional mandate of transparency and accountability.

It is inconceivable, however, how the publication of budgets, expenditures, contracts and loans and procurement plans of LGUs required in the assailed issuances could have infringed on the local fiscal autonomy of LGUs. Firstly, the issuances do not interfere with the discretion of the LGUs in the specification of their priority projects and the allocation of their budgets. The posting requirements are mere transparency measures which do not at all hurt the manner by which LGUs decide the utilization and allocation of their funds.

Secondly, it appears that even Section 352 of the LGC that is being invoked by the petitioners does not exclude the requirement for the posting of the additional documents stated in MC Nos. 2010-83 and 2011-08. Apparently, the mentioned provision requires the publication of "a summary of revenues collected and funds received, including the appropriations and disbursements of such funds." The additional requirement for the posting of budgets, expenditures, contracts and loans, and procurement plans are well- within the contemplation of Section 352 of the LGC considering they are documents necessary for an accurate presentation of a summary of appropriations and disbursements that an LGU is required to publish.

Finally, the Court believes that the supervisory powers of the President are broad enough to embrace the power to require the publication of certain documents as a mechanism of transparency. Moreover, the Constitution, which was drafted after long years of dictatorship and abuse of power, is now replete with numerous provisions directing the adoption of measures to uphold transparency and accountability in government, with a view of protecting the nation from repeating its atrocious past. In particular, the Constitution commands the strict adherence to full disclosure of information on all matters relating to official transactions and those involving public interest.

In the instant case, the assailed issuances were issued pursuant to the policy of promoting good governance through transparency, accountability and participation. The action of the respondent is certainly within the constitutional bounds of his power as alter ego of the President.

It is needless to say that the power to govern is a delegated authority from the people who hailed the public official to office through the democratic process of election. His stay in office remains a privilege which may be withdrawn by the people should he betray his oath of office. Thus, he must not frown upon accountability checks which aim to show how well he is performing his delegated power. For, it is through these mechanisms of transparency and accountability that he is able to prove to his constituency that he is worthy of the continued privilege.
