



This embodies the energy, dedication, and commitment of DILG Sugbo's personnel and field officers leadership under the of Provincial Director Atty. Ian Kenneth Lucero to reap more awards in 2023. This cover is a celebration of a transformative, bountiful, and impactful year for DILG Sugbo.





Cebu Governor Gwendolyn Garcia commended the Department of the Interior and Local Government (DILG) for consistently extending and expanding their services to the Sugboanons during the quarterly flagship program of the Cebu Provincial Government which brings services closer to the Cebuanos.

"In fact with our Caravan of Government Services, DILG is very visible. They give legal services in the morning. In the afternoon, out of their own pockets ha, they give away slippers and five kilos rice," said Garcia in her keynote speech during the Kadiwa ng Pangulo launch on July 17, 2023 at Robinsons Galleria Cebu.

From the 2nd semester of 2022 to the 4th quarter of 2023, the Sugbo Provincial Management and Coordinating Committee (PMCC) chaired by DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero has distributed a total of 17,315 pairs of "Libreng Tsinelas alang sa Sugboanon" (free slippers) and 776 packs of "Libreng SUGBUgas" (free rice); provided "Libreng Tupi" (free haircut) to 1,312 beneficiaries; and oriented 434 participants on basic fire safety and firefighting skills.

The DILG, also through Lucero and field officers, provided free lecture on Katarungang Pambarangay Law (KP on Wheels) to 2,699 punong barangay, members of Lupong Tagapamayapa, and other barangay officials; while Lucero and his fellow DILG and PMCC lawyers rendered "Libreng Serbisyo Legal" (free legal services) to 335 beneficiaries.

In her State of the Province Address on August 11 this year, Garcia likewise acknowledged the DILG first among the national government agencies which actively support the Caravan of Services.

Moreover, Garcia gave recognition for the first time to the DILG Regional Office led by Regional Director Leocadio Trovela and the DILG Sugbo Provincial Office headed by Lucero for their "invaluable contribution in the realization of the programs initiated by the Province of Cebu that significantly impacted the lives of Cebuanos".

The DILG was one of the partner government agencies and private organizations which were awarded with certificates of appreciation during the Gabii sa Pasasalamat on August 31 that concluded the month-long celebration of the Cebu Provincial Government's 454th founding anniversary.

It was also during one of the Caravan of Services when Garcia turned over to Lucero a brand new service vehicle in the presence of Trovela.

#Aboundin2023 Cebureapsawards

2023 has been a bountiful and impactful year for Cebu Province with more of its local government units bagging awards and recognitions for their outstanding performance and accomplishments.

To recall, DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero introduced the "Abound in 2023" vision to the DILG Cebu team reinforcing their commitment to assist the LGUs in the Province to excel and reap more awards.

He directed the cluster heads and program coordinators to strategize on how to enhance the performance in preparation for various audits and award systems of the Department such as Seal of Good Local Governance (SGLG), Good Financial Housekeeping (GFH), Seal of Child-Friendly Local Governance (SCFLG), Seal of Good Local Governance for Barangays (SGLGB), Anti-Drug Abuse Council (ADAC) Performance Audit, Peace and Order Council (POC) Audit, Local Legislative Award (LLA), Lupong Tagapamayapa Incentives Awards (LTIA), and DILG-7 Bansiwag Awards, among others.

Lucero likewise created core teams from the Provincial Office composed of one senior technical staff and one junior technical staff to assist each of the four clusters in the Province to give more focus on providing mentoring and coaching as well as on packaging entries of potential LGU awardees prior to the actual assessment or validation at the provincial level up to the regional and national level.

It is Lucero's belief that helping the LGUs improve their performance contributes to the Department's pursuit of local governance excellence and eventually translates to quality public service for the benefit of their constituents.

During the annual yearend assessment of DILG Sugbo, Lucero thanked all the field officers and technical and administrative staff of the Provincial Office for their hard work, efforts, and contributions to the milestones achieved by the Province during the year.

Nine local government units in Cebu Province earned this year's Seal of Good Local Governance (SGLG) from the Department of the Interior and Local Government.

This is a positive development from last year wherein four LGUs in Cebu namely Talisay City, Danao City, Sogod, and San Remigio were declared as recipients of the Department's most prestigious award.

This year, the Municipality of Sogod celebrated its fifth win, while Samboan and San Remigio secured their fourth win.

Securing the Seal for the second time were municipalities of Alegria and Tudela.

Joining the list of SGLG awardees for the first time were City of Bogo, Borbon, Daanbantayan, and Madridejos.

The local chief executives and other officials were joined by DILG-7 Director Leocadio Trovela, DILG-7 OIC Assistant Regional Director and DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero, Provincial Focal Person LGOO V Ginablle Ejoc, and concerned field officers during the national awarding ceremony graced by Secretary Atty. Benjamin Abalos, Jr on December 14 at the Manila Hotel.

The awardees received the Governance Assessment Report and SGLG Incentive Fund to finance their local development initiatives. Prior to the awarding, Lucero, field officers, and technical personnel of DILG Sugbo extended support to the LGUs during the provincial and national validation in July and September, respectively.

Lucero likewise joined the Regional Assessment Team, which he is a part of, during the Regional Calibration for the 2023 SGLG on July 20 together with provincial focal person LGOO V Ginable Ejoc.

The Sangguniang Panlungsod of Bogo City, Cebu was hailed as national winner of the 2023 Local Legislative Award (LLA) for the Component City Category on December 5, 2023 in Pasay City.

Vice Mayor Mayel Martinez together with other officials and Bogo CLGOO Mae Dura received the plaque of recognition and the P100,000 cash prize.

At the local level, DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero showed support to the entries of the province by convening the field officers and sanggunian secretaries of Bogo City, Bantayan, and Sogod - which were hailed as the provincial level winners - to prepare for the LLA regional assessment.

The DILG-7 Regional Awards Committee named Bogo City and the Municipality of Sogod as the regional winners of the 2023 Regional LLA.

The LLA aims to recognize the exemplary performance of Sangguniang Panlungsod and Bayan for legislating measures that help build impactful local administration and development from July 1, 2019 to June 30, 2022.















Bogo City, Bantayan, Sogod win 2023 LLA Sugbo

The Sangguniang Panlungsod of Bogo City and the Sangguniang Bayan of Bantayan and Sogod were hailed as winners of this year's Local Legislative Award (LLA) Sugbo.

Other finalists were Carcar City and Danao City for the Component Cities category, Compostela and Liloan under the 1st to 3rd Class Municipalities category, and Alcoy and Samboan for the 4th to 6th Class Municipalities category.

Recognizing the significant role of the local sanggunian as the highest policy-making body in their territories, DILG Sugbo and Philippine Councilors League (PCL) Cebu initiated the revival of the LLA, this time at the provincial level.

The LLA, last implemented nationwide in 2018, recognizes the exemplary performance of the Sangguniang Panlungsod and Sangguniang Bayan for legislating measures that help build the foundation of meaningful local administration and development.

Gracing as keynote speaker during the awarding ceremony on February 24 at the PCL Assembly at Bai Hotel, Cebu Third District Representative Pablo John Garcia said as legislators, their primary job is to come up with laws and resolutions that will serve their constituents who voted for them and whom they entrusted their future.

DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero said the delegation of legislative power springs from the principle that the local government is in a better position than the national government to act on purely local concerns.

40 Cebu LGUs pass 2022 GFH

The Province of Cebu, five of its component cities, and 34 of its municipalities passed the CY 2022 Good Financial Housekeeping (GFH) of the Department of the Interior and Local Government (DILG).

DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero congratulated Governor Gwendolyn Garcia and other Cebu GFH passers for adopting mechanisms that promote good governance through transparency, accountability, and participation.

"Kini nagpamatuod lamang sa sakto ug maayo gayud ang pagkadumala sa panudlanan sa atong probinsyal ug mga lokal nga kagamhanan sa Sugbo," he said.

The DILG released the official list of CY 2022 GFH passers totaling 1,450 out of the 1,715 LGUs assessed nationwide.

The GFH measures the financial transparency and institution of public reporting of the budgets and expenditures of local governments.

Criteria for passing the GFH are (a) the most recent available COA Audit Opinion is Unqualified or Qualified for CYs 2020 or 2021 as of November 4, 2022; and (b) compliance with Full Disclosure Policy – posting of all required financial documents in three conspicuous places and in the FDP portal for the 2nd to 4th quarter of CY 2021 and 1st quarter of CY 2022.

8 more LGUs pass 2022 GFH

Eight local government units in Cebu Province passed the CY 2022 Good Financial Housekeeping After Assessment Compliance, totaling to 48 out of 51 LGUs as GFH passers.

These eight LGUs are Toledo City and the municipalities of Carmen, Compostela, Consolacion, Malabuyoc, Medellin, Pilar, and San Francisco.

GFH recognizes the practice of the local government units of financial transparency and accountability and instituted public reporting of the budget and expenditure of local governments.

GFH is one of the factors being considered for an LGU to pass the first core area of Seal of Good Local Governance that is - Financial Administration.

The Cebu Province, including its component cities and municipalities, logged a significant 5.88 percent increase in the Full Disclosure Policy (FDP) compliance for the first quarter of 2023, from 90.19 percent for the first quarter last 2022 to 96.07 percent compliant this year.

Pursuant to DILG Memorandum Circular No. 2010-083, the FDP entails local government units (LGUs) to fully disclose their financial transactions by uploading their documents through the FDP portal and posting them in three conspicuous places to inform their constituents and gain public trust.

It also serves as one of the indicators for passing the Good Financial Housekeeping, aside from passing the Commission on Audit's assessment.

BOSS streamlines the application and renewal of business permits and licenses, which promotes ease of doing business under Republic Act No. 11032.

Around 48,000 business establishments were registered from January to March this year.



San Remigio, 25 Cebu brgys cleared from drugs



OC-IAITF mulls creation of new task force





Members of the One Cebu Inter-Agency Interdiction Task Force (OC-IAITF) agreed to form another task force focusing on the prosecution, case filing, and disposition of cases involving illegal drugs.

Trovela, who served as the Keynote Speaker and Guest of Honor, commended Team Cebu led by incumbent DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero for initiating the awarding ceremony, which he described as the "first in the region".

The DILG Sugbo, under the visionary leadership of Provincial Director Atty. Ian Kenneth Lucero, marked another milestone by enhancing its existing workload sharing arrangement now referred to as "Action-oriented and Partnership-driven Operation (APO) System 2.0" in the hopes of sustaining its progressive performance this year.

Lucero made the announcement on December 7 during the Socials Night with the field officers as part of the annual yearend assessment of DILG Sugbo.

To recall, Lucero first introduced the APO System in DILG Cebu City during his directorship in 2020 and 2021 as a clustering method mobilizing all technical officers as Barangay Local Government Operations Officers (BLGOOs), similar to a City or Municipal LGOO in the Province, to track the compliance and provide a more focused and enhanced assistance to their assigned barangays.

Inspired by the APO System which is being continued up to now in DILG Cebu City, he adopted the same decentralization approach upon his assumption in DILG Sugbo last year by creating core teams composed of one senior technical staff and one junior technical staff from the Provincial Office to help the program coordinators in collecting reports and assisting the clusters in mentoring and coaching as well as packaging the entries of potential LGU awardees in pursuance of the "Abound in 2023" vision of DILG Sugbo.

With the improved APO System 2.0, he mobilized all technical officers of DILG Sugbo as Overall Focal Person/Program Coordinator and Cluster Program Facilitators comprising the Provincial Monitoring Teams (PMTs) to intensify further the compliance of field offices with the Department's PPAs and closely assist the LGUs in Cebu in bagging more awards in the coming years.

"With the APO System, even if the designated program focal is not around, any of our technical staff can respond to any query or issue from the field or from our external clients anytime, thus there is no hiatus in public service," Lucero said.

"We are offering a solution to a felt need. That is APO SYSTEM 2.0, doing more with less," he added.

Lucero also thanked the field officers and the Provincial Office team for their hard work and efforts in helping the LGUs in the Province in reaping awards and recognition this year.

For his part, DILG-7 Director Leocadio Trovela commended Lucero and the DILG Sugbo team for their remarkable contributions to a fruitful 2023 for Region 7.

"For DILG Cebu, you are guided by C-E-B-U. C for competence, E for excellence, B for bravery, and U for unity...Ang DILG Cebu is pioneering talaga. Thank you for 2023. Ito ay banner year for Region 7 because of the number of awards of the LGUs," Trovela said.

DILG Sugboholds 1st Master Trainer training

The DILG Sugbo, through the initiative of Provincial Director Atty. Ian Kenneth Lucero, organized its first Master Trainer Training to equip field officers and technical staff of the Provincial Office on the basics of effective training delivery.

Lucero partnered with the University of San Carlos (USC) Psychological Center led by psychology professor Bre Segundo Abrea, Jr. as the training provider during the two-day activity on December 6 and 7 at Cebu Quincentennial Hotel in Cebu City as one of the highlights of the annual yearend assessment of DILG Sugbo.

Lucero, a law professor and lecturer for several years, said he felt the need to conduct such learning intervention for the technical officers of DILG Sugbo who are often tapped by internal and external clients to serve as knowledge sharers and to organize trainings.

"Through the Master Trainer training, you will train yourself to be a trainer, not train yourself to invite other trainers...Remember, you are being trained to become effective trainers. And when we say effective, it means doing the right thing," he said during his opening remarks.

Lucero closely worked with USC in coming up with the learning modules which are custom-fit to the needs of the DILG officers instead of the usual trainings that are mainly focused on local governance matters.

Among the topics discussed were guidelines for effective training, knowing the audience and their needs, creating impactful presentations, analyzing the need for training, planning the training, and principles of adult learning.

On the second day, the participants underwent a revalida wherein they were divided into four groups and were assigned to present various local governance topics each applying what they have learned.

Hailed as Master Trainers from each group were Bugsay Cluster Head Lelanie Lopez, Sibonga MLGOO Susan Tolentino, Dumanjug MLGOO Glenda Gabuya, and LGOO V Iris Arias of DILG Sugbo.

Lucero explained the quasi-judicial powers of sanggunian based on Republic Act 7160 or the Local Government Code of 1991, while NAPOLCOM-7 Legal Unit Chief Atty. Lecel Llamedo discussed the 2017 Rules on Administrative Cases in the Civil Service and gave tips on writing a decision.

After the training, the DILG trainers shall serve as knowledge sharers during capacity development activities within and outside their respective jurisdictions.

The first two batches of 4Ts trainers were organized last year centering on the Revised Katarungang Pambarangay Law and local legislation.



She also stressed that the Caravan of Provincial Government Services, which aims to bring services closer to the people, has now evolved to Caravan of Services and has expanded to include DILG, other government agencies, and private organizations, as well as the Kadiwa ng Pangulo Diskwentong Caravan of President Ferdinand Marcos Jr. To date, the Cebu Provincial Government has conducted a total of 147 Caravans since December 2019.

Garcia likewise thanked the regional and provincial directors of the different national agencies as well as law enforcement agencies for the all-out support to the Province's direction and position on issues concerning Cebu and the benefit of Cebuanos.
