




## ABOUT THE COVER

#### 14 Cebu LGUs bag SGLG award

Fourteen local government units from the Province of Cebu bagged the 2024 Seal of Good Local Governance (SGLG) from the Department of the Interior and Local Government during a ceremony on December 10 at the Manila Hotel.

The awardees were Cities of Bogo and Danao, and Municipalities of Alegria, Asturias, Carmen, Consolacion, Cordova, Daanbantayan, Medellin, Pinamungajan, San Remigio, Santa Fe, Sogod, and Tuburan.

Present during the ceremony were DILG-7 Director Leocadio Trovela, Assistant Regional Director Atty. Ian Kenneth Lucero, and DILG Sugbo OIC-Provincial Director Dr. Jesus Robel Sastrillo, Jr. together with cluster heads, field officers, provincial focal person, mayors, vice-mayors, and LGU representatives from Cebu Province.

Under Republic Act 11292, the SGLG is an award, incentive, honor, and recognition-based program for all LGUs and is a continuing commitment for LGUs to continually progress and improve their performance in various governance areas.































## CebulLGUsundergo 2024 SGLG national validation

Several local government units in Cebu Province, including Cordova, Consolacion, Bogo City, Asturias, Daanbantayan, Danao City, Madridejos, Balamban, Santa Fe, Tudela, Medellin, Tuburan, Pinamungajan, Carmen, and Alegria, underwent national validation for the 2024 Seal of Good Local Governance (SGLG) on September 10 to 13.

In addition to the 15 LGUs, the municipalities of San Remigio and Sogod were likewise endorsed for national validation but were no longer visited by the validators because they have passed the SGLG for two or more consecutive years.

Sangguniang Panlungsod member Ethel Gulane (City of Bogo) and Sangguniang Bayan member Atty. Ronamarie Therese Guaren (Municipality of Oslob) were hailed as winners of the first-ever Outstanding Lady Local Legislator Awards (OLLLA) in the cities and municipalities categories, respectively.

The event, spearheaded by DILG Sugbo and the Lady Local Legislators League (4L) Cebu Chapter in collaboration with the Cebu Provincial Government, celebrated the crucial role of women in governance.

Other finalists for the cities category were Hon. Vivian Canama (City of Bogo); Hon. Annabeth Cuizon (City of Lapu-Lapu); Hon. Jennifer Del Mar (City of Mandaue); Hon. Ma. Nevhell Francisco (City of Bogo); and Hon. Emily Jusay Juanillo (City of Bogo); while finalists for the municipalities category were Hon. Coca Nicohl Bustamante (Dalaguete); Hon. Janet Hubahib (Bantayan); Hon. Thelma Jordan (Liloan); Hon. Maricar Lumain (Badian); Hon. Annette Navarro (Pinamungajan); and Hon. Natileigh Marie Therese Sitoy (Cordova).

Cebu Governor Gwendolyn Garcia, keynote speaker during the November 26 awarding ceremony, commended the initiative, stating, "Women are created with a DNA for public service. We are redefining public service."

DILG-7 Regional Director Leocadio Trovela highlighted women as drivers of positive change, while Assistant Regional Director Atty. Ian Kenneth Lucero emphasized their pivotal role in advancing governance. Lucero chaired the OLLLA Awards Committee and led the team in crafting its guidelines and indicators.

Each winner received ₱500,000 worth of infrastructure projects funded by the Cebu Provincial Government, ₱20,000 cash, a plaque of recognition, and a copy of The Language of Local Legislation authored by ARD Lucero. Finalists were awarded ₱100,000 worth of projects, ₱10,000 cash, and similar tokens of recognition.

#### 47 LGUs named GFH passers

The GFH measures the financial transparency and institution of public reporting of budget and expenditures of local governments.



#### Poro officials oriented on quasijudicial functions

Philip Camiguing, Acting Director of the Preliminary Investigation, Administrative Adjudication and Prosecution Bureau and Officer-in-Charge of the Public Assistance and Corruption Prevention Bureau of the Office of the Ombudsman Visayas, presented the basics on conducting administrative investigation, while Atty. Grace Melanie Lacamiento, Attorney III of the DILG-7 Regional Legal Unit, gave tips on writing decisions.

## Mandatory bookkeeping training for Cebu SK treasurers conducted





DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero deployed the Cluster Heads and the City and Municipal Local Government Operations Officers of the Province to assist the Technical Education and Skills Development Authority (TESDA) in conducting the training for Sangguniang Kabataan (SK) treasurers in 10 clusters.

To recall, Lucero met with Governor Gwen Garcia on January 22 which was attended by TESDA Deputy Director General for Special Concerns Vidal Villanueva III, TESDA-7 Regional Director Ramon Evan Ruiz, TESDA-7 Assistant Regional Director and Cebu Provincial Director Floro Ringca, SK Federation Cebu President Loren Singco, and other officials.

TESDA acted on Garcia's recommendation to shorten the National Certificate III Qualification course from the usual 36 days to just one day.

Garcia said the training, which shall focus on journal keeping and financial reports, should be conducted per cluster or district as soon as possible considering that SK treasurers cannot assume office unless they have completed the said training from TESDA.

Under Republic Act No. 11768 amending Section 10 of RA 10742 or the SK Reform Act of 2015, SK treasurers are required to undergo a mandatory bookkeeping training from, and be duly certified by, the TESDA before assumption to office.



## DILG Sugbo hosts Bantay Korapsyon planning activity

The Department of the Interior and Local Government (DILG) Sugbo hosted the Bantay-Korapsyon - Program Management Office (BK-PMO) Forward Planning and Direction-Setting Activity from November 20 to 22, 2024 in Moalboal, Cebu.

The event gathered personnel and officials from DILG Central Office, BK-PMO, and regional focal persons, primarily legal officers and program coordinators, to review and refine the program's strategic direction for 2025-2030, ensuring alignment with the Philippine Development Plan (PDP) and DILG Strategic Plan.

The three-day session focused on finalizing BK's 2025 target deliverables, refining the BK Strategic Roadmap 2025-2030, and gathering input from regional focal persons to enhance implementation.

Technical personnel and lawyers from DILG-7 and DILG Sugbo provided assistance during the activity.





The DILG Sugbo, in partnership with the Cebu Provincial Government and Liga ng mga Barangay (LnB) Cebu Chapter, initiated the conduct of basic orientation for first-timer punong barangay in Cebu Province.

To accommodate the total number of participants, the activity was held at the Capitol Social Hall in two batches - 172 newly minted punong barangay on January 16 and 79 on February 6.

DILG Sugbo Provincial Director Atty. Ian Kenneth Lucero said the one-day activity was specifically designed for those who are new in public service to help equip them in performing their functions as leaders in their respective barangays.

Also serving as knowledge sharers were Moalboal Municipal Local Government Operations Officer Lyn Aguelo, Liloan Municipal Local Government Operations Officer Dr. James Andrew Andaya, and Sibonga Municipal Local Government Operations Officer Dr. Susan Tolentino who tackled the powers and functions of punong barangay; Listo si Kap; and barangay budgeting, respectively.

Department heads of the Cebu Provincial Government namely Dr. Roldan Saragena (Provincial Agriculturist's Office); Dr. Mary Rose Vincoy (Provincial Veterinary Office/Provincial Social Welfare and Development Office); Nerces Bispo (Provincial Planning and Development Office); and Atty. Pulchra Marie Acevedo (Secretary to the Sangguniang Panlalawigan) oriented the participants on the programs and initiatives of the Cebu Provincial Government such as the SUGBUsog, Enhanced Countryside Development, Caravan of Services, Sugbo Kahanas, Bugasan sa Kababayen-an Barangay, Sugbo Maisan, Sugbo Merkadong Barato, Sugbo Baboyan sa Limpyo ug Hapsay nga Tugkaran, Sugbo Merkadong Barato, Agri-Fishery Insurance, Agri-Fishery Clinic, ABAG Sugbo, Dog Population Control and Rabies, Veterinary Missions, Barangay Animal Health Animal Disease Monitoring, infrastructure projects like barangay roads, barangay hall/multi-purpose building, solar street lighting, covered court, and day care centers, and the disbursement and utilization of financial assistance to barangays.

It can be recalled that Lucero, in coordination with the Philippine Councilors League Cebu Chapter, likewise initiated a one-day training for first-time legislators in Cebu with no experience in legislation on July 15 last year which was graced by DILG Secretary Atty. Benjamin Abalos Jr, Garcia, and DILG-7 Director Leocadio Trovela.



### 8 Gebu LGUs hailed as 2024 ADAG National Awardees

Eight local government units in Cebu Province were declared as national awardees in the 2024 Anti-Drug Abuse Council (ADAC) Performance Awards for their exemplary implementation of anti-illegal drug initiatives in their localities.

The local chief executives of the Municipalities of Borbon, Carmen, Daanbantayan, Samboan, San Francisco, San Remigio, Sogod, and Tudela received the awards and cash incentives woth P150,000 during the awarding ceremony at the Manila Hotel on December 11.

Cebu Province is the only province from Region 7 with national awardees this year.

DILG-7 Director Leocadio Trovela, Assistant Regional Director Atty. Ian Kenneth Lucero, and DILG Sugbo OIC-Provincial Director Dr. Jesus Robel Sastrillo, Jr, along with cluster heads and field officers joined the mayors, vice-mayors, and LGU representatives from the Province of Cebu during the ceremony.

The outstanding ADACs were determined through the following criteria: 1) percentage of City/Municipal/Barangay ADAC functionality; 2) sustainability of drug-cleared or drug-free status; and 3) percentage of completion of Community-Based Drug Rehabilitation Program (CBDRP) graduates vs. enrollees.









### 75 LGUs to each get P13.33 M funding for safe, clean sources of water





Interior and Local Government Secretary Benhur Abalos on Wednesday announced that 75 local government units (LGUs) from across the country will each receive P13.33M to be used for the improvement of water supply and sanitation in their respective localities.

The amount will come from Support and Assistance Fund to Participatory Budgeting (SAFPB) Program, as prescribed by Republic Act 11975 or the General Appropriations Act (GAA) of 2024.

SAFPB is a groundbreaking initiative aimed at strengthening the partnership and collaboration between LGUs and civil society organizations (CSOs).

In his speech during the SAFPB event held in Cebu City, Abalos reminded the LGUs to be accountable and make sure that the fund will only be used on its intended purpose of improving their water sources and sanitation facilities.

"Pag binigay namin sa inyo ang benepisyo, may kasama itong mga responsibilidad. Even if you mean well, gamitin natin ng tama ang pribilehiyo na naipagkaloob sa inyo," he said.

The program covers projects ranging from the construction, expansion, and rehabilitation of Level III water supply systems or existing sanitary toilets and hygiene facilities for public places.

Abalos added that despite the recent improvements in water and sanitation, more localities still need crucial assistance from the government, especially those without an identified water source and those that are geographically isolated.

The DILG Chief elaborated that the program is in compliance with President Ferdinand Marcos, Jr.'s call of increasing local access to reliable and clean sources of water.

The program is also in line with the Philippines' Open Government Partnership (PH-OGP), which was institutionalized by the President through Executive Order No. 31 dated June 20, 2023.

"We shall comply with this directive of the President. Lalo na ngayon na may El Niño, we must not just govern but also foster a culture of genuine engagement so that workable solutions could flow from there," Abalos emphasized.

In the same speech, he also called for the support of the LGUs towards the Department's other initiatives, such as averting rising HIV-AIDS cases among the youth, the resurging problem of tuberculosis, and the urgent need to solve growth stunting brought by malnutrition.

Meanwhile, Department of Budget and Management (DBM) Secretary Amenah Pangandaman said the program also aims to "accelerate access to safely-managed and resilient water and sanitation services in lagging municipalities nationwide."




